## 90-Day Challenge

**T**aking the Habit-of-Health 90-Day Challenge is an easy way to find better health and to earn extra cash. When one of your Members joins the Challenge, she earns a rebate, and you and your upline Manager earn commissions.

### Here's how it works:



**Your New or Existing Member Joins the Challenge**

For you to receive commissions, your Member's 90-Day Challenge product purchase must be between 100–299 QV. Also, you must currently be enrolled in the Challenge or have completed the Challenge no later than the same month your Member joins the Challenge.

# Real Earnings!

**W**ant to build a business? The 90-Day Challenge is perfect for increasing your earning potential because you receive 30 percent commissions for each Member of your group enrolled in the program for each of the three months that they participate. Let's look at your earnings with just five people on the Challenge:

No. of Challenge Takers	Commissions per Month		
	1st month	2nd month	3rd month
5	\$165	\$165	\$165
10	\$330	\$330	\$330

With just five individuals participating in the 90-Day Challenge, you've earned \$495 over the three months they were on the program! Those five people also contributed 550 QV points over the three months. Imagine what will happen if you get 10 new people to join NSP using the 90-Day Challenge. Your commissions go up to 40 percent:

### Habit-of-Health Q&A

**Q:** How are commissions determined?

**A:** At the end of each month, we look at how many people in your group are taking the Challenge. You receive 30 percent commissions on each person enrolled in the program. If, in any given month, you have 10 people join NSP by signing up for the Challenge, you get 40 percent commissions! Your commissions will be added to your monthly bonus check.

**Q:** What if someone in my group signed up last month, but I didn't sign up until this month?

**A:** You will not receive Habit-of-Health commissions for that Member. You qualify to receive Habit-of-Health commissions on those in your group who sign up for the Challenge in the same month that you do, or in any month thereafter.

**Q:** What if you've completed the Challenge but don't receive products via AutoShip?

**A:** You will not receive Habit-of-Health commissions that month. To receive Habit-of-Health commissions in any given month, you must receive products via AutoShip in the same month.

**Q:** What if you're not enrolled?

## **What are the rules and regulations?**

### **Habit-of-Health 90-Day Challenge Participant Rules:**

- Any Member/Manager may enroll and participate in the 90-Day Challenge by choosing any Habit-of-Health package.
- The 90-Day Challenge is a three-month AutoShip agreement between the participant and Nature's Sunshine Products to purchase a special Habit-of-Health product package.
- To complete the Challenge, participants must select and receive via AutoShip a Habit-of-Health package for three consecutive months; this may not be changed during the 90-Day Challenge.

After their third Habit-of-Health order has been shipped, participants may change their product selection by going to [www.naturesunshine.com](http://www.naturesunshine.com).

### **Habit-of-Health 90-Day Challenge Sponsor Rules:**

- To receive 30% commissions when sponsoring others, the sponsoring account must be enrolled or must have completed the Challenge no later than the same month that their group Member begins participating in the Challenge. A sponsor who has completed the Challenge must continue to receive products via AutoShip (any products of their choice) to receive 30 percent commissions.
- 30% commissions are paid on Habit-of-Health package orders between 100–299 QV each of the three months of the 90-day Challenge.
- 30% commissions are paid monthly according to the NSP compensation plan. As always, Members/Managers are required to purchase 100 personal QV to receive compensation.
- Sponsors may receive 40% commissions (instead of 30%) on Challengers orders if they have at least **10 new** Members who join NSP with the 90-Day Challenge participating in any given month.
- Sponsors may be paid 30% commissions for three months even when *existing Members* join the 90-Day Challenge.
- When sponsors qualify for 30% commissions, all package rebates and commissions will be paid under 10-30-10 rules, regardless of rank of sponsor or participant.
- When sponsor does NOT qualify for 30% commissions, all product package payment is treated as normal volume under the Marketing plan rules.

### **AutoShip Features and Rules:**

- AutoShip product orders will be shipped once a month. Participants may choose to receive their order between the 1<sup>st</sup> and 25<sup>th</sup> of any given month and may cancel or alter their order at any time by going to [www.naturesunshine.com](http://www.naturesunshine.com).
- To receive the accumulating 5 percent discount per month, AutoShip participants must receive three consecutive monthly AutoShip orders. This accumulated amount is credited against the third consecutive AutoShip order.
- Accounts that receive three consecutive months of AutoShip orders and continue with an AutoShip order will then receive discounts of 5 percent on their AutoShip products granted monthly (limit of 299 QV).
- The AutoShip program requires a credit card for payment.
